© ICT NCP News is back after a July-August break caused by the Call 1 evaluation and the holidays!

#### **ICT Call 1 results**

The evaluation and selection of proposals from ICT Call 1 was completed at the end of July. Of 1836 proposals considered in the call, just 318 (17%) made it through to selection for grant agreement negotiations.

The retained list of proposals involves a total of 3121 participants<sup>1</sup>. Of these, 2820 are organisations based in the EU Member States

The negotiations with the successful proposers have – despite the summer holidays - in many cases already commenced. We would expect to be signing the grant agreements starting from the end of October.

### Call 1 Redress procedure

Along with their Evaluation Summary Report, proposers in ICT Call 1 were also informed of the new "Redress" procedure in the framework programme. Proposers who think that the Commission has in some way not properly handled their proposal in the evaluation can, within a reasonable time limit, make a <u>claim for redress</u>. These claims are examined by an internal committee. If the committee concludes that there was a shortcoming in the way the proposal

was handled, and as a consequence it was rejected when it might have been accepted, it can recommend a re-evaluation of the proposal.

Some 63 requests for redress have arisen from ICT Call 1, which is 3% of the 1836 proposals in the call. However, only a handful of the complainants suggest that the <u>Commission</u> has made a mistake - the purpose of the Redress procedure. Most are complaining that the <u>experts</u> have made a mistake, and that their proposal should have a higher mark. Despite the fact that they are clearly warned "the committee will not call into question the scientific or technical judgment of appropriately qualified experts", we have received many representations of material which was in the proposal. In a few cases, the complaint is based on information which wasn't in the proposal.

The Redress committee will work on all the cases through the month of September and will make recommendations for answers to the complaints and actions to be taken to the ICT Directors at the end of the month – it is the Director who has the responsibility for the call in his Directorate and who therefore responds to the complainants.

#### **Call 1 Ethical issues reviews**

Some 27 proposals on our list of the 318 selected for negotiation of a grant agreement have been judged to include significant ethical issues. Copies of the proposals have been sent of to our colleagues in the "Ethics" unit in DG Research, and they are presently being reviewed by their team of independent experts. While we go forward with the normal negotiation procedure for these proposals, no grant agreement will be offered until we have the recommendations of the experts and can incorporate them into the negotiation discussions. The ethical reviews are expected to be completed by the end of this month.

### **Second Infrastructures call**

DG INFSO opened on 19<sup>th</sup> June a second <u>Infrastructures call</u> under the "Capacities" Theme. It involves e-Science grid infrastructure projects and also Coordination and Support actions. Funded at €64m, the call closes on 20<sup>th</sup> September 2007 at 17h00. The evaluation will commence in October, with hearings for the highest-scoring proposals towards the end of that month.

# **Joint Call with Security**

On 3<sup>rd</sup> August (a little earlier than advertised, in order to get the job done before we all went on holiday), DG INFSO launched a first joint call with the Security Theme. Funded at €40m in total, the call covers four "foci". ICT's interest lies in focus 1, *Technology building blocks for creating, monitoring and managing secure, resilient and always-available information infrastructures*, which will take up €20m of the funding. This call closes on 29<sup>th</sup> November 2007 at 17h00; the evaluation of proposals will take place during January 2008.

An <u>information day</u> for proposers in this joint call will take place in Brussels on Thursday, 27<sup>th</sup> September at the Centre Albert Borschette in Brussels.

### Studies on ICT and Ageing

On 11<sup>th</sup> August our Directorate H launched a call for tender for a study on <u>ICT and Ageing</u>. The study is aimed at providing comprehensive information and understanding on ICT and ageing markets and existing barriers. It should help to identify and measure existing market barriers at national or European level as well as providing recommendations for their reduction to all relevant stakeholders. In addition the study should provide assistance to clustering and improved coordination between a number of ongoing EU RTD projects launched at the end of

FP6 as well as new ones expected in the first call of FP 7 related to ICT and Ageing. The deadline for the tender is 8<sup>th</sup> October 2007.

And on 25<sup>th</sup> August they also launched a call for tender for a study on <u>accessibility to ICT products and services</u> by disabled and elderly people. The purpose of the study is to provide a rigorous analysis of both existing and possible new legal approaches, as well as their impact, in order to promote e-Accessibility in the EU, taking into consideration users' interests and other relevant aspects including competitiveness and the functioning of the internal market. The deadline for this call is 1<sup>st</sup> October 2007.

## **FET Open first batch**

For research projects in our <u>Future and Emerging Technologies (FET) Open scheme</u>, the proposer must first submit a short proposal of the research idea (no more than five pages), and then those whose short proposals are well-rated are invited to develop and submit a full STREP proposal. The scheme is open continuously for submissions, with evaluations of the short proposals carried out promptly as they arrive.

The submitted full proposals are also evaluated in batches, and the first batch of full proposals for this framework programme was closed on 4<sup>th</sup> September. There are 23 STREPS and 6 Coordination Actions<sup>3</sup> in the batch. Their evaluation will take place during October 2007.

#### **New Head of Unit**

......And Mr. Ales Fiala has been appointed Head of Unit for the Unit F2, which manages the FET Open scheme. The current organigramme of the Directorate General is always available on europa.

## New guidance for participants in FP 7

The Commission has recently published two new documents to aid participants in the programme. The <u>Guidance notes on audit certification</u> is intended to guide project participants and their auditors in the preparation of *Certificates on the Financial Statements* and *Certificates on the Methodology* which are required of some participants in our projects.

A <u>Guide to Financial Issues</u> for participants has also now been released. The purpose of this guide is to help participants to understand and interpret the financial provisions of the Model Grant Agreement which they are offered.

# NCP Meeting for ICT Call 3

We have begun planning for a meeting of ICT NCPs in Brussels on 13<sup>th</sup> December 2007. The meeting will mainly focus on briefing you on the objectives of ICT Call 3, which we will have opened at the beginning of that month, but of course we will cover any other matters of interest. # **ICT Calls currently open**

<u>ICT Call 2</u> was launched on 12<sup>th</sup> June 2007. It covers nine objectives within five of the Challenges which have been set for ICT in FP7, and is funded at €477m. The call closes on 9<sup>th</sup> October 2007 at 17h00.

The ICT <u>FET Open</u> call was launched on 22<sup>nd</sup> December 2006. This is open continuously for the duration of the current Workprogramme. It involves only STREP and CA proposals. STREP proposals have to be submitted in two stages, with an initial five-page short proposal followed, if successful in the evaluation, by the full proposal at a later deadline.

A little earlier than planned, DG INFSO launched on 3<sup>rd</sup> August a first joint call with the Security Theme. Of the four "focuses" involved, our interest lies in focus 1, Technology building blocks for creating, monitoring and managing secure, resilient and always-available information infrastructures. The call is funded at €40m (€20m in the ICT focus) and closes on 29<sup>th</sup> November 2007 at 17h00.
