Separating regular languages by piecewise testable and unambiguous languages*

Abstract. Separation is a classical problem asking whether, given two sets belonging to some class, it is possible to separate them by a set from another class. We discuss the separation problem for regular languages. We give a PTIME algorithm to check whether two given regular languages are separable by a piecewise testable language, that is, whether a $\mathcal{B}\Sigma_1(<)$ sentence can witness that the languages are disjoint. The proof refines an algebraic argument from Almeida and the third author. When separation is possible, we also express a separator by saturating one of the original languages by a suitable congruence. Following the same line, we show that one can as well decide whether two regular languages can be separated by an unambiguous language, albeit with a higher complexity.

1 Introduction

Separation is a classical notion in mathematics and computer science. In general, one says that two structures L_1, L_2 from a class \mathbb{C} are *separable* by a structure L if $L_1 \subseteq L$ and $L_2 \cap L = \emptyset$. In this case, L is called a *separator*. In separation problems, the separator L is required to belong to a given class Sep. The problem asks whether two disjoint elements L_1, L_2 of \mathbb{C} can always be separated by an element of the class Sep. In the case that disjoint elements of \mathbb{C} cannot always be separated by an element of Sep, several natural questions arise:

- (1) given elements L_1, L_2 in \mathbb{C} , can we decide whether a separator exists in Sep?
- (2) if so, what is the complexity of this decision problem?
- (3) can we, in addition, compute a separator, and what is the complexity? In this context, it is known for example that separation of two context-free

In this context, it is known for example that separation of two context-free languages by a regular one is undecidable [9].

Separating regular languages. This paper looks at separation problems for the class C of regular languages, and for classes Sep closed under complement. Under this last condition, a separation algorithm for Sep entails an algorithm for deciding membership in Sep, *i.e.*, membership reduces to separability. Indeed, membership in Sep can be checked by testing whether the input language is Sep-separable from its complement.

Conversely, while finding a decidable characterization for Sep already requires a deep understanding of the subclass, the search for separation algorithms is intrinsically more difficult. Indeed, powerful tools are available to decide membership in Sep: one normally makes use of a recognizing device of the input language, viz. its syntactic monoid. A famous result along these lines is Schützenberger's Theorem [14], which states that a language is definable in first-order logic if and only if its syntactic monoid is aperiodic, a property one can easily decide.

Now for a separation algorithm, the question is whether the input languages are *sufficiently different*, from the point of view of the subclass Sep, to allow this to be witnessed by an element of Sep. Note that we cannot use standard methods on the recognizing devices, as was the case for the membership problem. We now have to decide whether there *exists* a recognition device of the given type that separates the input: we do not have it in hand, nor its syntactic monoid. An even harder question then is to actually construct the so-called separator in Sep.

Contributions. In this paper, we study this problem for two subclasses of the regular languages: piecewise testable languages and unambiguous languages.

Piecewise testable languages are languages that can be described by the presence or absence of scattered subwords up to a certain size within the words. Equivalently, these are the languages definable using $\mathcal{B}\Sigma_1(<)$ formulas, *i.e.*, first-order logic formulas that are boolean combinations of $\Sigma_1(<)$ formulas. A $\Sigma_1(<)$ formula is a first-order formula with a quantifier prefix \exists^* , followed by a quantifier-free formula. A well-known result about piecewise testable languages is Simon's Theorem [16], which states that a regular language is piecewise testable if and only if its syntactic monoid is \mathcal{J} -trivial. This property yields a decision procedure to check whether a language is piecewise testable, refined by Stern into a PTIME algorithm [18], of which the complexity has been improved by Trahtman [21].

The second class that we consider is the class of unambiguous languages, *i.e.*, languages defined by unambiguous products. This class has been given many equivalent characterizations [19]. For example, these are the FO²(<)-definable languages, that is, languages that can be defined in first-order logic using only two variables. Equivalently, this is the class $\Delta_2(<)$ of languages that are definable by a first-order formula with a quantifier prefix $\exists^*\forall^*$ and simultaneously by a first-order formula with a quantifier prefix $\forall^*\exists^*$. Note that consequently, all piecewise testable languages are FO²(<)-definable. It has been shown in [10] for $\Delta_2(<)$, and in [20] for FO²(<) that these are exactly the languages whose syntactic monoid belongs to the decidable class DA.

There is a common difficulty in the separation problems for these two classes. A priori, it is not known up to which level one should proceed in refining the candidate separators to be able to answer the question of separability. For piecewise testable languages, this refinement basically means increasing the size of the considered subwords. For unambiguous languages, it means increasing the size of the unambiguous products. For both of these classes, we are able to compute, from the two input languages, a number that suffices for this purpose. This entails decidability of the separability problem for both classes.

In both cases, we obtain a better complexity bound to answer the decision problem starting from NFAs: we show that two languages are separable if and only if the corresponding automata contain certain forbidden patterns of the same type. We prove that for piecewise testable languages this property can be decided in polynomial time wrt. the size of the automata and of the alphabet. For unambiguous languages this can be done in exponential space.

Related work. The classes of piecewise testable and unambiguous languages are varieties of regular languages. For such varieties, there is a generic connection found by Almeida [1] between profinite semigroup theory and the separation problem: Almeida has shown that two regular languages over A are separable by a language of a variety $A^*\mathcal{V}$ if and only if the topological closures of these two languages inside a profinite semigroup, depending only on $A^*\mathcal{V}$, intersect. Note that this theory does not give any information about how to actually construct the separator, in case two languages are separable. To turn Almeida's result into an algorithm deciding separability, we should compute representations of these topological closures, and test for emptiness of intersections of such closures.

So far, these problems have no generic answer and have been studied in an algebraic context for a small number of specific varieties. Deciding whether the closures of two regular languages intersect is equivalent to computing the so-called 2-pointlike sets of a finite semigroup wrt. the considered variety, see [1]. This question has been answered positively for the varieties of finite group languages [4,12], piecewise testable languages [3,2], star-free languages [8,7], and a few other varieties, but it was left open for unambiguous languages.

A general issue is that the topological closures may not be describable by a finite device. However, for piecewise testable languages, the approach of [3] builds an automaton over an extended alphabet, of exponential size wrt. the original alphabet, recognizing the closure of a regular language. The algorithm is polynomial wrt. the size of the original automaton (the construction was presented for deterministic automata but also works for nondeterministic ones). These automata admit the usual construction for intersection and can be checked for emptiness in Nlogspace. This yields an algorithm which, from two NFAs, decides separability by a piecewise testable language in time polynomial in the number of states of the NFAs, and exponential in the size of the original alphabet.

Our proof for separability by piecewise testable languages follows the same pattern as the method described above. A significant improvement is that we show that non-separability is witnessed by paths of the same shape in both automata, which yields an algorithm providing better complexity: it runs in polynomial time in both the size of the automata and in the size of the alphabet. Also, we do not make use of the theory of profinite semigroups: we work only with elementary concepts. We have described this algorithm in [13]. Furthermore, we show how to compute from the input languages an index that suffices to separate them. We use the same technique for unambiguous languages. Recently, Czerwinski et. al. [6] also provided a PTIME algorithm for deciding separability by piecewise testable languages, but do not provide the computation of such an index.

Due to space constraints, some proofs only appear in the full version of this paper.

2 Preliminaries

We fix a finite alphabet $A = \{a_1, \ldots, a_m\}$. We denote by A^* the free monoid over A. The empty word is denoted by ε . For a word $u \in A^*$, the smallest $B \subseteq A$ such that $u \in B^*$ is called the *alphabet* of u and is denoted by $\mathsf{alph}(u)$.

Separability. Given languages L, L_1, L_2 , we say that L separates L_1 from L_2 if

$$L_1 \subseteq L$$
 and $L_2 \cap L = \emptyset$.

Given a class Sep of languages, we say that the pair (L_1, L_2) is Sep-separable if some language $L \in \text{Sep}$ separates L_1 from L_2 . Since all classes we consider are closed under complement, (L_1, L_2) is Sep-separable if and only if (L_2, L_1) is, in which case we simply say that L_1 and L_2 are Sep-separable.

We are interested in two classes Sep of separators: the class of piecewise testable languages, and the class of unambiguous languages.

Piecewise Testable Languages. We say that a word u is a piece of v, if

$$u = b_1 \cdots b_k$$
, where $b_1, \dots, b_k \in A$, and $v \in A^*b_1A^* \cdots A^*b_kA^*$.

For instance, ab is a piece of $bb\underline{a}cc\underline{b}a$. The size of a piece is its number of letters. A language $L\subseteq A^*$ is $piecewise\ testable$ if there exists $\kappa\in\mathbb{N}$ such that membership of w in L only depends on the pieces of size up to κ occurring in w. We write $w\sim_{\kappa}w'$ when w and w' have the same pieces of size up to κ . Clearly, \sim_{κ} is a congruence of finite index. Therefore, a language is piecewise testable if and only if it is a union of \sim_{κ} -classes for some $\kappa\in\mathbb{N}$. In this case, the language is said to be of $index\ \kappa$. It is easy to see that a language is piecewise testable if and only if it is a finite boolean combination of languages of the form $A^*b_1A^*\cdots A^*b_kA^*$.

Piecewise testable languages are languages definable by $\mathcal{B}\Sigma_1(<)$ formulas, that is, boolean combinations of first-order formulas of the form:

$$\exists x_1 \dots \exists x_n \ \varphi(x_1, \dots, x_n),$$

where φ is quantifier-free. For instance, $A^*b_1A^*\cdots A^*b_kA^*$ is defined by the formula $\exists x_1 \ldots \exists x_k \left[\bigwedge_{i < k} (x_i < x_{i+1}) \wedge \bigwedge_{i \leqslant k} b_i(x_i) \right]$, where the first-order variables x_1, \ldots, x_k are interpreted as positions, and where b(x) is the predicate testing that position x carries letter b.

We denote by $PT[\kappa]$ the class of all piecewise testable languages of index κ or less, and by $PT = \bigcup_{\kappa} PT[\kappa]$ the class of all piecewise testable languages. Given $L \subseteq A^*$ and $\kappa \in \mathbb{N}$, the smallest $PT[\kappa]$ -language containing L is

$$[L]_{\sim \kappa} = \{ w \in A^* \mid \exists u \in L \text{ and } u \sim_{\kappa} w \}.$$

In general however, there is no smallest PT-language containing a given language. **Unambiguous Languages.** A product $L = B_0^* a_1 B_1^* \cdots B_{k-1}^* a_k B_k^*$ is called unambiguous if every word of L admits exactly one factorization witnessing its membership in L. The number k is called the *size* of the product. An unambiguous language is a finite disjoint union of unambiguous products. Observe that unambiguous languages are connected to piecewise testable languages. Indeed, it was proved in [15] that the class of unambiguous languages is closed under boolean operations. Moreover, languages of the form $A^*b_1A^*\cdots A^*b_kA^*$ are unambiguous, witnessed by the product $(A \setminus \{b_1\})^*b_1(A \setminus \{b_2\})^* \cdots (A \setminus \{b_k\})^*b_kA^*$. Therefore, piecewise testable languages form a subclass of the unambiguous languages.

Many equivalent characterizations for unambiguous languages have been found [19]. From a logical point of view, unambiguous languages are exactly the languages definable by an $FO^2(<)$ formula [20]. Here, $FO^2(<)$ denotes the two-variable restriction of first-order logic. Another logical characterization which further illustrates the link with piecewise testable languages (i.e., $\mathcal{B}\Sigma_1(<)$ definable languages) is $\Delta_2(<)$. A $\Sigma_2(<)$ formula is a first-order formula of the form:

$$\exists x_1 \ldots \exists x_n \ \forall y_1 \ldots \forall y_m \ \varphi(x_1, \ldots, x_n, y_1, \ldots, y_m),$$

where φ is quantifier-free. A language is $\Delta_2(<)$ -definable if it can be defined both by a $\Sigma_2(<)$ formula and the negation of a $\Sigma_2(<)$ formula. It has been proven in [10] that a language is unambiguous if and only if it is $\Delta_2(<)$ -definable.

For two words w, w', we write, $w \cong_{\kappa} w'$ if w, w' belong to the same unambiguous products of size κ or less. We denote by $UL[\kappa]$ the class of all languages that are unions of \cong_{κ} -classes, and we let $UL = \bigcup_{\kappa} UL[\kappa]$. Since unambiguous languages are closed under boolean operations, UL is the class of all unambiguous languages. Given $L \subseteq A^*$ and $\kappa \in \mathbb{N}$, the smallest $UL[\kappa]$ -language containing L is

$$[L]_{\cong \kappa} = \{ w \in A^* \mid \exists u \in L \text{ and } u \cong_{\kappa} w \}.$$

Again, in general there is no smallest *UL*-language containing a given language. **Automata.** A nondeterministic finite automaton (NFA) over A is denoted by a tuple $\mathcal{A} = (Q, A, I, F, \delta)$, where Q is the set of states, $I \subseteq Q$ the set of initial states, $F \subseteq Q$ the set of final states and $\delta \subseteq Q \times A \times Q$ the transition relation. The *size* of an automaton is its number of states plus its number of transitions. We denote by L(A) the language of words accepted by A. Given a word $u \in A^*$, a subset B of A and two states p, q of A, we denote

- by $p \xrightarrow{u} q$ a path from state p to state q labeled u,
 by $p \xrightarrow{\subseteq B} q$ a path from p to q of which all transitions are labeled over B,
- by $p \xrightarrow{=B} q$ a path from p to q of which all transitions are labeled over B, with the additional demand that every letter of B occurs at least once along it.

Given a state p, we denote by scc(p, A) the strongly connected component of p in \mathcal{A} (that is, the set of states that are reachable from p and from which p can be reached), and by $alph_scc(p, A)$ the set of labels of all transitions occurring in this strongly connected component. Finally, we define the restriction of A to a subalphabet $B \subseteq A$ by $\mathcal{A} \upharpoonright_B \stackrel{\text{def}}{=} (Q, B, I, F, \delta \cap (Q \times B \times Q))$.

Separation by piecewise testable languages

Since $PT[\kappa] \subset PT$, $PT[\kappa]$ -separability implies PT-separability. Furthermore, for a fixed κ , it is obviously decidable whether two languages L_1 and L_2 are $PT[\kappa]$ separable: there is a finite number of $PT[\kappa]$ languages over A, and for each of them, one can test whether it separates L_1 and L_2 . The difficulty for deciding whether L_1 and L_2 are PT-separable is to effectively compute a witness $\kappa = \kappa(L_1, L_2)$, i.e., such that L_1 and L_2 are PT-separable if and only if they are $PT[\kappa]$ -separable. Actually, we show that PT-separability is decidable, by different arguments:

- (1.a) We give a necessary and sufficient condition on NFAs recognizing L_1 and L_2 , in terms of forbidden patterns, to test whether L_1 and L_2 are PT-separable.
- (1.b) We give a polynomial time algorithm to check this condition.
 - (2) We compute $\kappa \in \mathbb{N}$ from L_1, L_2 , such that PT-separability and $PT[\kappa]$ separability are equivalent for L_1 and L_2 . Hence, if the PTIME algorithm answers that L_1 and L_2 are PT-separable, then $[L_1]_{\sim \kappa}$ is a valid PT-separator.

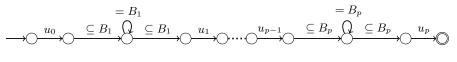


Fig. 1. A $(\boldsymbol{u}, \boldsymbol{B})$ -path

Let us first introduce some terminology to explain the necessary and sufficient condition on NFAs. Let \mathcal{A} be an NFA over A. For $u_0, \ldots, u_p \in A^*$ and nonempty subalphabets $B_1, \ldots, B_p \subseteq A$, let $\mathbf{u} = (u_0, \ldots, u_p)$ and $\mathbf{B} = (B_1, \ldots, B_p)$. A (\mathbf{u}, \mathbf{B}) -path in \mathcal{A} is a successful path (leading from the initial state to a final state of \mathcal{A}), of the form shown in Fig. 1.

Recall that edges denote sequences of transitions (see section Automata, p. 5). Therefore, if \mathcal{A} has a $(\boldsymbol{u}, \boldsymbol{B})$ -path, then $L(\mathcal{A})$ contains a language of the form $u_0(x_1y_1^*z_1)u_1\cdots u_{p-1}(x_py_p^*z_p)u_p$, where $\mathsf{alph}(x_i)\cup \mathsf{alph}(z_i)\subseteq \mathsf{alph}(y_i)=B_i$.

Given NFAs A_1 and A_2 , a pair $(\boldsymbol{u}, \boldsymbol{B})$ is a witness of non PT-separability for (A_1, A_2) if there is a $(\boldsymbol{u}, \boldsymbol{B})$ -path in both A_1 and A_2 . For instance in Fig. 2, $\boldsymbol{u} = (\varepsilon, c, \varepsilon)$ and $\boldsymbol{B} = (\{a, b\}, \{a\})$ define such a witness of non PT-separability.



Fig. 2. A witness of non *PT*-separability for (A_1, A_2) : $u = (\varepsilon, c, \varepsilon)$, $B = (\{a, b\}, \{a\})$

We are now ready to state our main result regarding PT-separability.

Theorem 1. Let A_1 and A_2 be two NFAs over A. Let $L_1 = L(A_1)$ and $L_2 = L(A_2)$. Let k_1, k_2 be the number of states of A_1 resp. A_2 . Define $p = \max(k_1, k_2) + 1$ and $\kappa = p|A|2^{2^{|A|}|A|(p|A|+1)}$. Then the following conditions are equivalent:

- (1) L_1 and L_2 are PT-separable.
- (2) L_1 and L_2 are $PT[\kappa]$ -separable.
- (3) The language $[L_1]_{\sim \kappa}$ separates L_1 from L_2 .
- (4) There is no witness of non PT-separability in (A_1, A_2) .

Condition (2) yields an algorithm to test PT-separability of regular languages. Indeed, one can effectively compute all piecewise testable languages of index κ (of which there are finitely many), and for each of them, one can test whether it separates L_1 and L_2 . Before proving Theorem 1, we show that Condition (4) can be tested in polynomial time (and hence, PT-separability is PTIME decidable).

Proposition 2. Given two NFAs A_1 and A_2 , one can determine whether there exists a witness of non PT-separability in (A_1, A_2) in polynomial time wrt. the sizes of A_1 and A_2 , and the size of the alphabet.

Proof. Let us first show that the following problem is in PTIME: given states p_1, q_1, r_1 of \mathcal{A}_1 and p_2, q_2, r_2 of \mathcal{A}_2 , determine whether there exist a nonempty $B \subseteq A$ and paths $p_i \xrightarrow{\subseteq B} q_i \xrightarrow{(=B)} q_i \xrightarrow{\subseteq B} r_i$ in \mathcal{A}_i for both i = 1, 2.

To do so, we compute a decreasing sequence $(C_i)_i$ of alphabets overapproximating the greatest alphabet B that can be chosen for labeling the loops around q_1 and q_2 . Note that if there exists such an alphabet B, it should be contained in

$$C_1 \stackrel{\text{def}}{=} \mathsf{alph_scc}(q_1, \mathcal{A}_1) \cap \mathsf{alph_scc}(q_2, \mathcal{A}_2).$$

Using Tarjan's algorithm to compute strongly connected components in linear time, one can compute C_1 in linear time as well. Then, we restrict the automata to alphabet C_1 , and we repeat the process to obtain the sequence $(C_i)_i$:

$$C_{i+1} \stackrel{\mathrm{def}}{=} \mathsf{alph_scc}(q_1, \mathcal{A}_1 \restriction_{C_i}) \cap \mathsf{alph_scc}(q_2, \mathcal{A}_2 \restriction_{C_i}).$$

After a finite number n of iterations, we obtain $C_n = C_{n+1}$. Note that $n \leq |\mathsf{alph}(\mathcal{A}_1) \cap \mathsf{alph}(\mathcal{A}_2)| \leq |A|$. If $C_n = \varnothing$, then there exists no nonempty B for which there is an (=B)-loop around both q_1 and q_2 . If $C_n \neq \varnothing$, then it is the maximal nonempty alphabet B such that there are (=B)-loops around q_1 in \mathcal{A}_1 and q_2 in \mathcal{A}_2 . It then remains to determine whether there exist paths $p_1 \xrightarrow{\subseteq B} q_1 \xrightarrow{\subseteq B} r_1$ and $p_2 \xrightarrow{\subseteq B} q_2 \xrightarrow{\subseteq B} r_2$, which can be performed in linear time.

To sum up, since the number n of iterations such that $C_n = C_{n+1}$ is bounded by |A|, and since each computation is linear wrt. the size of \mathcal{A}_1 and \mathcal{A}_2 , one can decide in PTIME wrt. to both |A| and these sizes whether such a pair of paths occurs.

Now we build from \mathcal{A}_1 and \mathcal{A}_2 two new automata $\tilde{\mathcal{A}}_1$ and $\tilde{\mathcal{A}}_2$ as follows. The procedure first initializes $\tilde{\mathcal{A}}_i$ as a copy of \mathcal{A}_i . Denote by Q_i the state set of \mathcal{A}_i . For each 4-uple $\tau=(p_1,r_1,p_2,r_2)\in Q_1^2\times Q_2^2$ such that there exist $B\neq\varnothing$, two states $q_1\in Q_1,q_2\in Q_2$ and paths $p_i\stackrel{\subseteq B}{\longrightarrow} q_i\stackrel{=B}{\longrightarrow} q_i\stackrel{\subseteq B}{\longrightarrow} r_i$ in \mathcal{A}_i both for i=1 and i=2, we add in both $\tilde{\mathcal{A}}_1$ and $\tilde{\mathcal{A}}_2$ a new letter a_τ to the alphabet, and "summary" transitions $p_1\stackrel{a_\tau}{\longrightarrow} r_1$ and $p_2\stackrel{a_\tau}{\longrightarrow} r_2$. Since there is a polynomial number of tuples

 $(p_1, q_1, r_1, p_2, q_2, r_2)$, the above shows that computing these new transitions can be performed in PTIME. So, computing $\tilde{\mathcal{A}}_1$ and $\tilde{\mathcal{A}}_2$ can be done in PTIME.

By construction, there exists some pair $(\boldsymbol{u}, \boldsymbol{B})$ such that \mathcal{A}_1 and \mathcal{A}_2 both have a $(\boldsymbol{u}, \boldsymbol{B})$ -path if and only if $L(\tilde{\mathcal{A}}_1) \cap L(\tilde{\mathcal{A}}_2) \neq \emptyset$. Since both $\tilde{\mathcal{A}}_1$ and $\tilde{\mathcal{A}}_2$ can be built in PTIME, this can be decided in polynomial time as well.

The following is an immediate consequence of Theorem 1 and Proposition 2.

Corollary 3. Given two NFAs, one can determine in polynomial time, with respect to the number of states and the size of the alphabet, whether the languages recognized by these NFAs are PT-separable. \Box

In the rest of the section, we sketch the proof of Theorem 1. The implications $(3) \iff (2) \implies (1)$ are obvious. To show $(1) \implies (2)$, we introduce some terminology. Let us fix an arbitrary order $a_1 < \cdots < a_m$ on A.

(p, B)-patterns. Let $B = \{b_1, \dots, b_r\} \subseteq A$ with $b_1 < \dots < b_r$, and let $p \in \mathbb{N}$. We say that a word $w \in A^*$ is a (p, B)-pattern if $w \in (B^*b_1B^* \cdots B^*b_rB^*)^p$. The number p is called the *power* of w. For example, set $B = \{a, b, c\}$ with a < b < c. The word $bb\underline{a}a\underline{b}ab\underline{c}c\underline{a}c\underline{b}aba\underline{c}a$ is a (2, B)-pattern but not a (3, B)-pattern.

 ℓ -templates. An ℓ -template is a sequence $T=t_1,\ldots,t_\ell$ of length ℓ , such that every t_i is either a letter or a nonempty subset of the alphabet A. The main idea behind ℓ -templates is that they yield decompositions of words that can be detected using pieces and provide a suitable decomposition for pumping. Unfortunately, not all ℓ -templates are actually detectable. Because of this we restrict ourselves to a special case of ℓ -templates. An ℓ -template is said to be unambiguous if all pairs t_i, t_{i+1} are either two letters, two incomparable sets or a set and a letter that is not included in the set. For example, $T=a,\{b,c\},d,\{a\}$ is unambiguous, while $T'=\underline{b},\{\underline{b},c\},d,\{a\}$ and $T''=a,\{b,\underline{c}\},\{\underline{c}\},\{a\}$ are not.

p-implementations. A word $w \in A^*$ is a *p-implementation* of an ℓ -template $T = t_1, \ldots, t_\ell$ if $w = w_1 \cdots w_\ell$ and for all i either $t_i = w_i \in A$ or $t_i = B \subseteq A$, $w_i \in B^*$ and w_i is a (p, B)-pattern. For example, $abccbbcbdaaaa = a.(\underline{bccbbc}b.\underline{c}b).d.(\underline{aa}aa)$ is a 2-implementation of the 4-template $T = a, \{b, c\}, d, \{a\}$, since $\underline{bccbbc}b$ is a $(2, \{b, c\})$ -pattern and $\underline{aa}aa$ is a $(2, \{a\})$ -pattern.

We now prove (1) \Longrightarrow (2) by contraposition: we show that if $w_1 \in L_1, w_2 \in L_2$ are such that $w_1 \sim_{\kappa} w_2$, then for any h, one can build $v_1 \in L_1$ and $v_2 \in L_2$ such that $v_1 \sim_h v_2$. Therefore, non- $PT[\kappa]$ -separability entails non-PT-separability.

Lemma 4. From regular languages L_1, L_2 , we can compute $p \in \mathbb{N}$ such that whenever L_1 and L_2 both contain p-implementations of the same ℓ -template T, then L_1 and L_2 are not PT-separable.

Proof. Let p be greater than the number of states of NFAs recognizing L_1, L_2 . Let w_1, w_2 be p-implementations of an ℓ -template $T = t_1, \ldots, t_\ell$. Fix $h \in \mathbb{N}$. Whenever t_i is a set B, the corresponding factors in w_1, w_2 are (p, B)-patterns. By choice of p, these factors can be pumped into (h, B)-patterns in $v_1 \in L_1$ and $v_2 \in L_2$, respectively. It is then easy to check that $v_1 \sim_h v_2$. Hence, L_1 and L_2 are not PT[h]-separable. Since h is arbitrary, L_1 , L_2 are not PT-separable. \square

It remains to prove that if two words contain the same pieces of a large enough size κ , they are both p-implementations of a common unambiguous ℓ -template, where p is the number introduced in Lemma 4. We split the proof in two parts. We begin by proving that it is enough to look for ℓ -templates for a bounded ℓ .

Lemma 5. Let $p \in \mathbb{N}$. Every word is the p-implementation of some unambiguous N_A -template, for $N_A = 2^{2^{|A|}|A|(p|A|+1)}$.

Proof. We first get rid of the unambiguity condition. Any ambiguous ℓ -template T can be reduced to an unambiguous ℓ' -template T' with $\ell' < \ell$ by merging the ambiguities. It is then straightforward to reduce any p-implementation of T into a p-implementation of T'. Therefore, it suffices to prove that every word is the p-implementation of some (possibly ambiguous) N_A -template.

The choice of N_A comes from Erdös-Szekeres' upper bound of Ramsey numbers. Indeed, a complete graph with edges labeled over $c = 2^{|A|}$ colors, there exists a complete monochromatic subgraph of size m = p|A| + 1 provided the graph has at least 2^{mc} vertices (see [5] for a short proof that this bound suffices).

Observe that a word is always the p-implementation of the ℓ -template which is just the sequence of its letters. Therefore, in order to complete our proof, it suffices to prove that if a word is the p-implementation of some ℓ -template T with $\ell > N_A$, then it is also the p-implementation of an ℓ' -template with $\ell' < \ell$.

Fix a word w, and assume that w is the p-implementation of some ℓ -template $T=t_1,\ldots,t_\ell$ with $\ell>N_A$. By definition, we get a decomposition $w=w_1\cdots w_\ell$. We construct a complete graph Γ with vertices $\{0,\ldots,\ell\}$ and edges labeled by subsets of A. For all i< j, we set $\mathsf{alph}(w_{i+1}\cdots w_j)$ as the label of the edge (i,j). Since Γ has more than $\ell>N_A$ vertices, by definition of N_A there exists a complete monochromatic subgraph with p|A|+1 vertices $\{i_1,\ldots,i_{p|A|+1}\}$. Let B be the color of the edges of this monochromatic subgraph. Let $w'=w_{i_1+1}\cdots w_{i_{p|A|+1}}$. By construction, w' is the concatenation of $p|A|\geqslant p$ words with alphabet exactly B. Hence w' is a (p,B)-pattern. It follows that w is a p-implementation of the ℓ' -template $t_1,\ldots,t_{i_1},B,t_{i_{p|A|+2}},\ldots,t_\ell$ with $\ell'=\ell-p|A|+1$. Hence $\ell'<\ell$ (except for the trivial case p=|A|=1).

The next lemma proves that once ℓ and p are fixed, given w it is possible to describe by pieces ℓ -templates that w p-implements, as long as they are unambiguous.

Lemma 6. Let $\ell, p \in \mathbb{N}$. From p and ℓ , we can compute κ such that for every pair of words $w \sim_{\kappa} w'$ and every unambiguous ℓ -template T, w' is a p-implementation of T whenever w is a (p+1)-implementation of T.

We finish the proof of the implication $(1) \Longrightarrow (2)$ by assembling the results. Let p be greater than the number of states of NFAs recognizing L_1 and L_2 , as introduced in the proof of Lemma 4. Let N_A be as introduced in Lemma 5 for p+1, and let $\kappa=|A|(p+1)N_A$ be as introduced in Lemma 6. Fix $h>\kappa$ and assume that we have $w_1\in L_1$ and $w_2\in L_2$ such that $w_1\sim_{\kappa} w_2$. By Lemma 5, w_1 is the (p+1)-implementation of some unambiguous N_A -template T. Moreover,

it follows from Lemma 6 that w_2 is a p-implementation of T. By Lemma 4, we finally obtain that L_1 and L_2 are not PT-separable.

The implication $(1) \Longrightarrow (4)$ of Theorem 1 is easy to show by contraposition, see [13, Lemma 2]. The remaining implication $(4) \Longrightarrow (1)$ can be shown using Lemma 6. For a direct proof, see [13, Lemma 3], where the key for getting a forbidden pattern out of two non-separable languages is to extract a suitable p-implementation using Simon's Factorization Forest Theorem [17].

4 Separation by unambiguous languages

This section is devoted to proving that UL-separability is a decidable property. Again, the result is twofold. Using an argument that is analogous to property (2) of Theorem 1 in Section 3, we prove that given L_1, L_2 , it is possible to compute a number κ such that L_1, L_2 are UL-separable if and only if they are $UL[\kappa]$ -separable. It is then possible to test separability by using a brute-force approach that tests all languages in $UL[\kappa]$.

The second part of our theorem is an algorithm providing only a 'yes/no' answer, but running in exponential space. This algorithm is more complicated than the one of Section 3. In this case, we cannot search for a witness of non-separability directly on the NFAs of the languages. A precomputation is needed. We present the algorithm before stating our main theorem.

UL-intersection. Let $A_1 = (Q_1, A, I_1, F_1, \delta_1)$, $A_2 = (Q_2, A, I_2, F_2, \delta_2)$ be NFAs. The purpose of our precomputation is to associate to all 4-uples $(q_1, r_1, q_2, r_2) \in Q_1^2 \times Q_2^2$ a set $\alpha(q_1, r_1, q_2, r_2)$ of subalphabets. Intuitively, $B \in \alpha(q_1, r_1, q_2, r_2)$ if, for all $\kappa \in \mathbb{N}$, there are two words w_1, w_2 such that

- $(1) B = \mathsf{alph}(w_1) = \mathsf{alph}(w_2),$
- (2) $q_1 \xrightarrow{w_1} r_1$, and $q_2 \xrightarrow{w_2} r_2$,
- (3) $w_1 \cong_{\kappa} w_2$.

The precomputation of $\alpha: Q_1^2 \times Q_2^2 \to 2^{2^A}$ is performed via a fixpoint algorithm. For all $(q_1, r_1, q_2, r_2) \in Q_1^2 \times Q_2^2$, we initially set $\alpha(q_1, r_1, q_2, r_2) = \{\{a\} \mid q_1 \xrightarrow{a} r_1 \text{ and } q_2 \xrightarrow{a} r_2\}$. The sets are then saturated with the following two operations:

- (1) When $\alpha(p_1, q_1, p_2, q_2) = B$ and $\alpha(q_1, r_1, q_2, r_2) = C$, then add $B \cup C$ to $\alpha(p_1, r_1, p_2, r_2)$.
- (2) When $B \in \alpha(q_1, q_1, q_2, q_2) \cap \alpha(r_1, r_1, r_2, r_2)$ and there exist words $w_1, w_2 \in B^*$ such that $q_1 \xrightarrow{w_1} r_1$ and $q_2 \xrightarrow{w_2} r_2$ then add B to $\alpha(q_1, r_1, q_2, r_2)$.

Since every set $\alpha(q_1, r_1, q_2, r_2)$ only grows with respect to inclusion, and is bounded from above by 2^A , the computation terminates. It is straightforward to see that α can be computed in EXPSPACE using a fixpoint algorithm. Finally, we say that L_1, L_2 have *empty UL-intersection* if $\alpha(q_1, r_1, q_2, r_2) = \emptyset$ for all $q_1, q_2 \in I_1, I_2$ and $r_1, r_2 \in F_1, F_2$. We now state the main theorem of this section.

Theorem 7. Let A_1 and A_2 be two NFAs over alphabet A. Let $L_1 = L(A_1)$ and $L_2 = L(A_2)$. Let k_1, k_2 be the number of states of A_1 , resp. A_2 . Define $\kappa = (2k_1k_2 + 1)(|A| + 1)^2$. Then the following conditions are equivalent:

- (1) L_1 and L_2 are UL-separable.
- (2) L_1 and L_2 are $UL[\kappa]$ -separable.
- (3) The language $[L_1]_{\cong \kappa}$ separates L_1 from L_2 .
- (4) L_1, L_2 have empty UL-intersection.

As in the previous section, Conditions (2) and (4) yield algorithms for testing whether two languages are separable. Moreover, it can be shown that empty UL-intersection can be tested in Pspace from α . Therefore, we get the following corollary.

Corollary 8. It is decidable whether two regular languages can be separated by an unambiguous language. Moreover, this can be done in EXPSPACE in the size of the NFAs recognizing the languages.

Observe that by definition of $UL[\kappa]$, the bound κ is defined in terms of unambiguous products. A rephrasing of the theorem would be: there exists a separator iff there exists one defined by a boolean combination of unambiguous products of size κ . It turns out that the same κ also works for $FO^2(<)$, *i.e.*, there exists a separator iff there exists one defined by an $FO^2(<)$ -formula of quantifier rank κ . This can be proved by minor adjustements to the proof of Theorem 7.

The proof of Theorem 7 is inspired from techniques used in [11] and relies heavily on the notion of (p, B)-patterns. It works by induction on the size of the alphabet. There are two non-trivial implications: $(1) \Longrightarrow (4)$ and $(4) \Longrightarrow (3)$. We now provide an insight into the most difficult one, *i.e.*, $(4) \Longrightarrow (3)$. The following proposition is used to prove this.

Proposition 9. Let $B \subseteq A$ and $\kappa = (2k_1k_2+1)(|B|+1)^2$. For all pairs of words $w_1 \cong_{\kappa} w_2$ such that $B = \mathsf{alph}(w_1) = \mathsf{alph}(w_2)$ and all pairs of states $(q_1, r_1) \in Q_1^2$ and $(q_2, r_2) \in Q_2^2$ such that $q_1 \xrightarrow{w_1} r_1$ and $q_2 \xrightarrow{w_2} r_2$, we have $B \in \alpha(q_1, r_1, q_2, r_2)$.

Observe that a consequence of Proposition 9 is that as soon as there exists $w_1 \in L_1, w_2 \in L_2$ such that $w_1 \cong_{\kappa} w_2$ (i.e., $[L_1]_{\cong_{\kappa}}$ is not a separator), there exists a witness of nonempty UL-intersection. This is the contrapositive of $(4) \Longrightarrow (3)$.

5 Conclusion

We proved separation results for both piecewise testable and unambiguous languages. Both results provide a means to decide separability. In the PT case, we even prove that this can be done in PTIME. Moreover, in both cases we give an insight on the actual separator by providing a bound on its size, should it exist.

There remain several interesting questions in this field. First, one could consider other subclasses of regular languages, the most interesting one being full first-order logic. Separability by first-order logic has already been proven to be decidable using semigroup theory [7]. However, this approach is difficult to understand, and it yields a costly algorithm that only provides a yes/no answer, without insight about a possible separator. Another question is to get tight

complexity bounds. For unambiguous languages for instance, it is likely that our EXPSPACE upper bound can be improved, and even for piecewise testable languages, we do not know any tight bounds.

A final observation is that right now, we have no general approach and are bound to use *ad-hoc* techniques for each subclass. An interesting direction would be to invent a general framework that is suitable for this problem in the same way that monoids are a suitable framework for decidable characterizations.

Appendix

A Proofs of Section 3

A.1 Proof of Condition (4) Theorem 1

We prove Condition (4). We prove (4) \Longrightarrow (1) and (3) \Longrightarrow (4).

(4) \Longrightarrow (1). We proceed by contraposition. Assume that L_1, L_2 are not PT-separable. Recall that \mathcal{A}_1 and \mathcal{A}_2 are NFAs for L_1, L_2 and that k_1, k_2 are their sizes. Set $p = \max(k_1, k_2) + 1$ and $\ell = 2^{2^{|\mathcal{A}|}|\mathcal{A}|(p|\mathcal{A}|+1)}$. We prove that L_1, L_2 both contain p-implementations of some N_A -template T and use T to construct a witness of non PT-separability in $(\mathcal{A}_1, \mathcal{A}_2)$.

Let κ be as defined in Lemma 6 from ℓ and p. Since L_1, L_2 are not PT-separable, there exist $w_1 \in L_1$ and $w_2 \in L_2$ such that $w_1 \sim_{\kappa} w_2$. By choice of ℓ, p and Lemma 5, w_1 must be the p-implementation of some unambiguous ℓ -template T. Applying Lemma 6, we obtain that w_1, w_2 are both $(\max(k_1, k_2))$ -implementations of T.

Let $\mathbf{B} = (B_1, \dots, B_n)$ be the subsequence of elements T that are sets. Let $\mathbf{u} = (u_0, \dots, u_n)$, where u_i is the word obtained by concatenating the letters that are between B_i and B_{i+1} in T. By definition (\mathbf{u}, \mathbf{B}) is a factorization pair.

Because w_1 is a $(\max(k_1, k_2))$ -implementation, the path used to read w_1 in \mathcal{A}_1 must traverse loops labeled by each of the B_i , and clearly this is a $(\boldsymbol{u}, \boldsymbol{B})$ -path. Using the same argument we get that the path of w_2 in \mathcal{A}_2 is also a $(\boldsymbol{u}, \boldsymbol{B})$ -path. Therefore $(\boldsymbol{u}, \boldsymbol{B})$ is a witness of non PT-separability.

(3) \Longrightarrow (4). Again, we proceed by contraposition. Set κ as in Theorem 1 and assume that there exists a factorization pair $(\boldsymbol{u}, \boldsymbol{B})$ that is a witness of non PT-separabilty. We prove that $[L_1]_{\sim\kappa}$ is not a separator.

Set $\mathbf{B} = (B_1, \dots, B_n)$ and $\mathbf{u} = (u_0, \dots, u_n)$. By definition, this means that there exist $w_1 \in L_1$ and $w_2 \in L_2$ of the form

$$u_0v_1u_1v_2\cdots v_nu_n$$

where the words such that $\operatorname{alph}(v_i) = B_i$ and v_i contains a $(\kappa, B_i) - pattern$. It is straightforward to see that $w_1 \sim_{\kappa} w_2$. Therefore, $w_2 \in L_2 \cap [L_1]_{\sim \kappa}$ and $[L_1]_{\sim \kappa}$ is not a separator.

A.2 Proof of Lemma 6

Lemma 6. Let $\ell, p \in \mathbb{N}$. From p and ℓ , we can compute κ such that for every pair of words $w \sim_{\kappa} w'$ and every unambiguous ℓ -template T, w' is a p-implementation of T whenever w is a (p+1)-implementation of T.

Proof. We prove that the lemma holds for $\kappa = |A|p\ell$. Let $w \sim_{\kappa} w'$ and let $T = \{t_1, t_2, \ldots, t_{\ell}\}$ be an unambiguous ℓ -template such that w is a p + 1-implementation of T. We begin by giving a decomposition of w' and prove that it indeed witnesses the fact that w' is a p-implementation of T. We define

 $w'_1 \cdots w'_\ell = w'$ inductively as follows: assume that the factors are defined up to w'_i and let u be such that $w' = w'_1 \cdots w'_i \cdot u$. If t_{i+1} is a letter then w'_{i+1} is just the first letter of u, otherwise $t_{i+1} = B \subseteq A$, and in that case w'_{i+1} is the largest prefix of u which contains only letters of B. We will prove that $w'_1 \cdots w'_\ell$ witnesses that w' is a p-implementation of T. The proof relies on Claim 1 stated below.

To every unambiguous ℓ -template $T = \{t_1, t_2, \dots, t_\ell\}$ and $p \in \mathbb{N}$, we associate a piece $v_{T,p} = v_1 \cdots v_\ell$, such that for all i:

$$v_i = \begin{cases} a & \text{if } t_i = a \in A \\ (b_1 \cdots b_n)^p & \text{if } t_i = \{b_1, \dots, b_n\} \subseteq A \end{cases}$$

By definition, if w is a p-implementation of T then $v_{T,p}$ is a piece of w. Consider $v_{T,1} = v_1 \cdots v_\ell$. A piece v is incompatible with T when v is of the following form: $v = v_1 \cdots v_i \cdot u \cdot v_{i+1} \cdots v_\ell$ such that if t_i (resp. t_{i+1}) is a set the first letter (resp. last letter) of u is not in t_i (resp. t_{i+1}).

Claim 1 If w is a 1-implementation of some unambiguous ℓ -template T, then there is no piece of w that is incompatible with T.

Proof. This is a consequence of the fact that T is unambiguous.

We now prove that for all i, $w'_i = a$ if t_i is the letter a or w'_i is a word over some $B \subseteq A$ containing a (p, B)-pattern if $t_i = B$. We proceed by induction, assume that this is true up to w'_i and consider w'_{i+1} . Set $v_{T,1} = v_1 \cdots v_\ell$ and $v_{T,p+1} = r_1 \cdots r_\ell$. By induction hypothesis and by choice of κ , we know that $v_{i+1} \cdots v_\ell$ and $r_{i+1} \cdots r_\ell$ are pieces of $w_{i+1} \cdots w_\ell$. We distinguish two cases depending on the nature of t_{i+1} .

Case 1: t_{i+1} is some letter a. We have to prove that $w'_{i+1} = a$. Assume that $w'_{i+1} = b \neq a$. Then $v_1 \cdots v_i \cdot b \cdot v_{i+1} \cdots v_\ell$ must be a piece of w' and therefore a piece of w ($w \sim_{\kappa} w'$). We prove that this piece is incompatible with T, which contradicts Claim 1. Observe that by definition of w_i , if t_i is a set then $b \notin t_i$ (otherwise it would have been included in t_i). Therefore $v_1 \cdots v_i \cdot b \cdot v_{i+1} \cdots v_\ell$ is incompatible with T.

Case $2: t_{i+1}$ is a set $B = \{b_1, \ldots, b_n\}$. By construction, w_{i+1} contains only letters in B. Therefore, we have to prove that it contains a (p, B)-pattern. Assume that it does not. By contruction, the first letter of w_{i+2} is some letter $c \notin B$. If $w_{i+1} = \varepsilon$, then $v_1 \cdots v_i \cdot c \cdot v_{i+1} \cdots v_\ell$ must be a piece of w'. Using an argument similar to the previous case, we can prove that this piece is incompatible with T, which contradicts Claim 1.

Otherwise, let b be the first letter of w_{i+1} . Recall that by definition, r_{i+1} contains a (p+1,B)-pattern and that $r_{i+1}\cdots r_\ell$ is a piece of $w_{i+1}\cdots w_\ell$. Therefore, since w_{i+1} does not contain a (p,B)-pattern, the last suffix of r_{i+1} containing a (1,B)-pattern must fall in w_{i+2} and consequently, $v_{i+1}\cdots v_\ell$ must be a piece of $w_{i+2}\cdots w_\ell$. It follows that $v_1\cdots v_i\cdot b\cdot c\cdot v_{i+1}\cdots v_\ell$ is a piece of w' and of w ($w\sim_\kappa w'$). By definition, $c\not\in t_{i+1}$. Moreover, by construction, if t_i is a set, then $b\not\in t_i$. Therefore, $v_1\cdots v_i\cdot b\cdot c\cdot v_{i+1}\cdots v_\ell$ is incompatible with T which contradicts Claim 1 since it is also a piece of w.

B Proofs of Section 4

In this appendix, we prove Theorem 7. There are two non-trivial directions: (1) \Longrightarrow (4) and (4) \Longrightarrow (3). As we explained, our proof relies heavily on the notion of (p, B)-patterns. The appendix is divided into two parts, each devoted to one direction. For the rest of this appendix A_1, A_2 are automata recognizing L_1, L_2 and k_1, k_2 are their number of states.

B.1 $(4) \Longrightarrow (3)$

As we explained in the main paper, this is a consequence of Proposition 9.

Proposition 9. Let $B \subseteq A$ and $\kappa = (2|Q_1||Q_2|+1)(|A|+1)^2$. For all pairs of words $w_1 \cong_{\kappa} w_2$ such that $B = \mathsf{alph}(w_1) = \mathsf{alph}(w_2)$ and all pairs of states $(q_1, r_1) \in Q_1^2$ and $(q_2, r_2) \in Q_2^2$ such that $q_1 \xrightarrow{w_1} r_1$ and $q_2 \xrightarrow{w_2} r_2$, we have $B \in \alpha(q_1, r_1, q_2, r_2)$.

We begin by giving a brief outline. We first fix a large enough p. Intuitively, p needs to be large enough so that a run on a word of length p contains a repeated state. Then, we show that κ is large enough in order to ensure that w_1, w_2 are both a (2p, B)-pattern or neither of them is. In both cases, we are then able to decompose w_1, w_2 into sequences of factors that are pairwise equivalent and use a smaller alphabet. We then apply induction on these factors and derive the result by reconstructing w_1, w_2 using the two operations in the construction of α . We first define our notion of decomposition. For the remainder of this section, we assume $B = \{b_1, \dots, b_n\}$ is fixed.

Decompositions for (B, p)-patterns. Consider $w \in B^*$. Recall that by definition, w is a (B, p)-pattern iff $w \in (B^*b_1 \cdots B^*b_n B^*)^p$. This means that w can be decomposed into a sequence of factors witnessing its membership in $(B^*b_1 \cdots B^*b_n B^*)^p$:

$$w = \prod_{i=1}^{pn} (w_i \cdot b_{i \mod n}) \cdot w_{kn+1}.$$

To each word w we associate a unique such decomposition for the largest integer p such that w is a (B,p)-pattern. We say that $w \in B^*$ admits a (B,p)-decomposition iff w is a (B,p)-pattern but not a (B,k+1)-pattern. It is straightforward to see that if w admits a (B,p)-decomposition then there exists an integer l such that pn < l < (p+1)n, and

$$w = \prod_{i=1}^{l} (w_i \cdot b_{i \mod n}) \cdot w_{l+1}, \tag{1}$$

such that for all i, $b_{i \mod m} \notin w_i$. The integer l is called the *length* of the decomposition. We give an example of a word that admits a (B, 1)-decomposition (of length 5) in Figure (3).

$$\underbrace{\mathbf{bcacbbcccaccbaa}}_{w_1} \underbrace{w_2w_3}_{w_4} \underbrace{w_5}_{w_5} \underbrace{w_6}_{w_6}$$

Fig. 3. w = bcacbbcccaccbaa over $B = \{a, b, c\}$ admits a (B, 1)-decomposition

A useful result about (B, p)-decompositions is that they can be detected using an unambiguous product with large enough size. Moreover, using products of the same size, one can also describe the products that are satisfied by the factors in the (B, p)-decomposition.

Lemma 10. Let $p, \tilde{\kappa} \in \mathbb{N}$ such that $\kappa > \tilde{\kappa} + p(|B| + 1)$. Then for every pair of words $u \cong_{\kappa} v$ and all $h \leqslant p$, u admits a (B,h)-decomposition iff v admits a (B,h)-decomposition. Moreover, the associated decompositions, as described in (1), are of the same length l:

$$u = \prod_{i=1}^{l} (u_i \cdot b_{i \mod n}) \cdot u_{l+1}$$
$$v = \prod_{i=1}^{l} (v_i \cdot b_{i \mod n}) \cdot v_{l+1}$$

and for all $i, u_i \cong_{\tilde{\kappa}} v_i$.

Proof. For the sake of readability, for all $b \in B$ we will write B_b for the alphabet $B \setminus \{b\}$ and for every number i, we will write c_i for $b_{i \mod n}$. Assume that u admits a (B, h)-decomposition and consider the associated decomposition:

$$u = \prod_{i=1}^{l} (u_i \cdot c_i) \cdot u_{l+1}$$

Consider the following unambiguous product:

$$P = \prod_{i=1}^{l} (B_{c_i} \cdot c_i) \cdot B_{c_{l+1}}.$$

By construction, P is of size $l \leq p(|A|+1) < \kappa$ and $u \in P$. Therefore, $v \in P$ and v admits an (B, h)-decomposition together with the associated decomposition:

$$v = \prod_{i=1}^{l} (v_i \cdot c_i) \cdot v_{l+1}.$$

It remains to prove that for all i, $u_i \cong_{\tilde{\kappa}} v_i$. Assume that u_i belongs to some unambiguous product P' of size $\tilde{\kappa}$. This means that u is in the unambiguous product:

$$P'' = \prod_{j=1}^{i-1} (B_{c_j} \cdot c_j) \cdot (P' \cdot c_i) \cdot \prod_{j=i+1}^{l} (B_{c_j} \cdot c_j) \cdot B_{c_{l+1}}.$$

Because P'' is of size at most $\tilde{\kappa} + k(|A| + 1)$, we have $v \in P''$. By assumption on the decomposition of v, this means that $v_i \in P'$ and we are done.

We now move to the proof of Proposition 9. Set w_1, w_2, q_1, q_2, r_1 and r_2 as in the statement and recall that $\{b_1, \ldots, b_n\} = B$ of size n. We begin by fixing the size of the patterns for which we will look in w_1, w_2 . Set $p = k_1k_2$, (recall that $k_1 = |Q_1|$ and $k_2 = |Q_2|$). A pigeonhole principle argument proves that for $q_0, \ldots, q_p \in Q_1$ and $r_0, \ldots, r_p \in Q_2$, there exist i < j such that both $q_i = q_j$ and $r_i = r_j$. We will look for (B, p)-patterns.

Recall that $\kappa = (2p+1)(n+1)^2$ (n=|B|). We prove Proposition 9 by induction on n. By Lemma 10, either both w_1, w_2 admit (B, h)-decompositions for some h < 2p or both w_1, w_2 do not admit (B, h)-decompositions for $h \leqslant 2p$. We treat these two cases separately.

Case 1: both w_1 and w_2 admit (B, h)-decompositions for h < 2p. Observe that $\tilde{\kappa} = (2p+1)(|B|)^2$ implies that $\kappa > \tilde{\kappa} + 2p(|B|+1)$. Therefore, we can apply the second part of Lemma 10 to w_1 and w_2 . This yields the following decompositions:

$$w_1 = \prod_{i=1}^{l} (u_i \cdot b_{i \mod n}) \cdot u_{l+1}$$

$$w_2 = \prod_{i=1}^{l} (v_i \cdot b_{i \mod n}) \cdot v_{l+1}$$

such that for all i, $u_i \cong_{\tilde{\kappa}} v_i$. By hypothesis, there exist runs $q_1 \xrightarrow{w_1} r_1$ and $q_2 \xrightarrow{w_2} r_2$. These runs can be decomposed as sequences of subruns for each factor in the decomposition.

$$\begin{array}{l} q_1 = q_1^1 \xrightarrow{u_1} r_1^1 \xrightarrow{b_1} q_1^2 \xrightarrow{u_2} r_1^2 \xrightarrow{b_2} \cdots q_1^{l+1} \xrightarrow{u_{l+1}} r_1^{l+1} = r_1 \\ q_2 = q_2^1 \xrightarrow{v_1} r_2^1 \xrightarrow{b_1} q_2^2 \xrightarrow{v_2} r_2^2 \xrightarrow{b_2} \cdots q_2^{l+1} \xrightarrow{v_{l+1}} r_2^{l+1} = r_2 \end{array}$$

Observe that by definition of the decompositions u_i, v_i use a strict subalphabet of B. Therefore, by choice of $\tilde{\kappa}$ the induction hypothesis can be used and for all i, $\mathsf{alph}(u_i) = \mathsf{alph}(v_i) \in \alpha(q_1^i, r_1^i, q_2^i, r_2^i)$. Moreover, by definition of α , for all $i \in \{b_{i \mod n}\} \in \alpha(r_1^i, q_1^{i+1}, r_2^i, q_2^{i+1})$. Therefore, by application of the Operation (1) in the construction of α we get that

$$B = \mathsf{alph}(w_1) = \bigcup_{i \leqslant l+1} \mathsf{alph}(u_i) \cup \bigcup_{i \leqslant l} \{b_{i \ mod \ n}\} \in \alpha(q_1, r_1, q_2, r_2)$$

which finishes this case.

Case 2: both w_1 and w_2 do not admit (B, h)-decompositions for $h \leq 2k$. This means that w_1, w_2 are both (B, 2p)-patterns. A simple argument as in the proof of Lemma 10 shows that w_1, w_2 can be decomposed into three factors:

$$w_1 = u_{\mathfrak{l}} \cdot u_{\mathfrak{c}} \cdot u_{\mathfrak{r}}$$
$$w_2 = v_{\mathfrak{l}} \cdot v_{\mathfrak{c}} \cdot v_{\mathfrak{r}}$$

such that $u_{\mathfrak{l}} \cong_{\kappa-p(n+1)} v_{\mathfrak{l}}$, $u_{\mathfrak{r}} \cong_{\kappa-p(n+1)} v_{\mathfrak{r}}$, $u_{\mathfrak{c}} \cong_{\kappa-p(n+1)} v_{\mathfrak{c}}$ and $u_{\mathfrak{l}}$, $v_{\mathfrak{l}}$, $u_{\mathfrak{r}}$, $v_{\mathfrak{r}}$ admit (B,p)-decompositions. By hypothesis, there exist runs $q_1 \xrightarrow{w_1} r_1$ and $q_2 \xrightarrow{w_2} r_2$. These runs can then be decomposed as follows:

$$\begin{array}{c} q_1 \xrightarrow{u_{\mathfrak{l}}} p_1 \xrightarrow{u_{\mathfrak{c}}} s_1 \xrightarrow{u_{\mathfrak{r}}} r_1 \\ q_2 \xrightarrow{v_{\mathfrak{l}}} p_2 \xrightarrow{v_{\mathfrak{c}}} s_2 \xrightarrow{v_{\mathfrak{r}}} r_2 \end{array}$$

We prove that there are intermediary states p_1', p_2', s_1' and s_2' occurring in the runs on $u_{\mathfrak{l}}, v_{\mathfrak{l}}, u_{\mathfrak{r}}$ and $v_{\mathfrak{r}}$ such that:

- (1) $\exists C_{\mathfrak{l}}, C_{\mathfrak{r}} \subseteq B$ such that $C_{\mathfrak{l}} \in \alpha(q_1, p'_1, q_2, p'_2)$ and $C_{\mathfrak{r}} \in \alpha(s'_1, r_1, s'_2, r_2)$.
- (2) $B \in \alpha(p'_1, p'_1, p'_2, p'_2)$ and $B \in \alpha(s'_1, s'_1, s'_2, s'_2)$.
- (3) There exist $x_1, x_2 \in B^*$ such that $p'_1 \xrightarrow{x_1} s'_1$ and $p'_2 \xrightarrow{x_2} s'_2$.

Using Items 2 and 3 we can use Operation (2) in the construction of α and obtain that $B \in \alpha(p'_1, s'_1, p'_2, s'_2)$. Then by Operation (1) and Item 1, we conclude that $B \in \alpha(q_1, r_1, q_2, r_2)$ which ends the proof.

Observe that the third point is immediate as soon as p'_1, p'_2, s'_1 and s'_2 have been defined as occurring in the runs on $u_{\mathfrak{l}}, v_{\mathfrak{l}}, u_{\mathfrak{r}}$ and $u_{\mathfrak{r}}$. Therefore we only need to prove that there exist states satisfying the first two points. We only do the proof for p'_1, p'_2 occurring in the runs on $u_{\mathfrak{l}}, v_{\mathfrak{l}}$, the proof is symmetrical for s'_1, s'_2 .

Observe that $\kappa - p(n+1) > \tilde{\kappa} + p(n+1)$. Therefore, we can apply Lemma 10 to $u_{\mathfrak{l}}$ and $v_{\mathfrak{l}}$. This yields the following decompositions:

$$u_{\mathfrak{l}} = \prod_{i=1}^{l} (u_i \cdot b_{i \mod n}) \cdot u_{l+1}$$

$$v_{\mathfrak{l}} = \prod_{i=1}^{l} (v_i \cdot b_{i \mod n}) \cdot v_{l+1}$$

such that for all $i, u_i \cong_{\tilde{\kappa}} v_i$. Moreover the length l of the decompositions is l > pn. Recall that there are runs $q_1 \xrightarrow{u_l} p_1$ and $q_2 \xrightarrow{v_l} p_2$ These runs can be decomposed as sequences of subruns for each factor in the decomposition.

$$\begin{aligned} q_1 &= q_1^1 \xrightarrow{u_1} p_1^1 \xrightarrow{b_1} q_1^2 \xrightarrow{u_2} p_1^2 \xrightarrow{b_2} \cdots q_1^{l+1} \xrightarrow{u_{l+1}} p_1^{l+1} = r_1 \\ q_2 &= q_2^1 \xrightarrow{v_1} p_2^1 \xrightarrow{b_1} q_2^2 \xrightarrow{v_2} p_2^2 \xrightarrow{b_2} \cdots q_2^{l+1} \xrightarrow{v_{l+1}} p_2^{l+1} = r_2 \end{aligned}$$

Observe that by definition of the decompositions u_i, v_i use a strict subalphabet of B. Therefore, by choice of $\tilde{\kappa}$ the induction hypothesis can be used and for all i, $\mathsf{alph}(u_i) = \mathsf{alph}(v_i) \in \alpha(q_1^i, p_1^i, q_2^i, p_2^i)$. Moreover, by definition of α , for all $i \in \{b_{i \bmod n}\} \in \alpha(p_1^i, q_1^{i+1}, p_2^i, q_2^{i+1})$. Recall that i > pn, therefore, by choice of p, there exist numbers $0 \le j < j' \le p$ such that $q_1^{1+nj} = q_1^{1+nj'}$ and $q_2^{1+nj} = q_2^{1+nj'}$. Set $p_1' = q_1^{1+nj}$ and $p_2' = q_2^{1+|B|j}$. By applying Operation (1) in the definition of α we get

$$\begin{split} &\alpha(p_1',p_1',p_2',p_2')\ni \bigcup_{nj< i\leqslant nj'}\operatorname{alph}(u_i)\cup \bigcup_{nj< i\leqslant nj'}\{b_{i\ mod\ n}\}\subseteq B\\ &\alpha(q_1,p_1',q_2,p_2')\ni \bigcup_{1\leqslant i\leqslant nj}\operatorname{alph}(u_i)\cup \bigcup_{1\leqslant i\leqslant nj}\{b_{i\ mod\ n}\}\subseteq B \end{split}$$

Moreover, observe that since j < j'

$$\bigcup_{nj < i \leqslant nj'} \{b_{i \mod n}\} = B$$

We conclude that $B \in \alpha(p'_1, p'_1, p'_2, p'_2)$ which finishes the proof.

$$B.2 \quad (1) \Longrightarrow (4)$$

This direction in Theorem 7 is a consequence of the following proposition.

Proposition 11. Let $(q_1,r_1) \in Q_1^2$ and $(q_2,r_2) \in Q_2^2$ and assume that $B \in \alpha(q_1,r_1,q_2,r_2)$. Then for all $\kappa \in \mathbb{N}$, there exist $w_1 \cong_{\kappa} w_2$ such that $B = alph(w_1) = alph(w_2)$, $q_1 \xrightarrow{w_1} r_1$ and $q_2 \xrightarrow{w_2} r_2$.

Before proving Proposition 11, we briefly explain how it can be used to prove that $(1) \Longrightarrow (4)$. It is simple to derive from Proposition 11 that if there exists a witness of non-empty UL-intersection, then for all κ there can be no $UL[\kappa]$ separator. This is exactly the contrapositive of $(1) \Longrightarrow (4)$. We finish with the proof of Proposition 11.

The proof goes by induction on the number of operations required to generate $B \in \alpha(q_1, r_1, q_2, r_2)$. If no operation was used then $B = \{a\}$ is a singleton and $q_1 \xrightarrow{a} r_1$ and $q_2 \xrightarrow{a} r_2$. Moreover, for all $\kappa \in \mathbb{N}$, $\alpha \cong_{\kappa} a$.

Otherwise we distinguish two cases depending on the last operation that was used in order to generate $B \in \alpha(q_1, r_1, q_2, r_2)$.

First Case: Operation (1). There exist states p_1, p_2 and $C \cup D = B$ such that $\alpha(q_1, p_1, q_2, p_2) = C$, $\alpha(p_1, r_1, p_2, r_2) = D$. Set $\kappa \in \mathbb{N}$, by induction hypothesis, there exists u_1, u_2, v_1, v_2 such that $u_1 \cong_{\kappa} u_2, v_1 \cong_{\kappa} v_2$, $\operatorname{alph}(u_1) = \operatorname{alph}(u_2) = C$, $\operatorname{alph}(v_1) = \operatorname{alph}(v_2) = D$, $q_1 \xrightarrow{u_1} p_1$, $p_1 \xrightarrow{v_1} r_1$, $q_2 \xrightarrow{u_2} p_2$ and $p_2 \xrightarrow{v_2} r_2$. Set $w_1 = u_1 v_1$ and $w_2 = u_2 v_2$. It is straightforward to see that $w_1 \cong_{\kappa} w_2, q_1 \xrightarrow{w_1} r_1$, $q_2 \xrightarrow{w_2} r_2$ and $\operatorname{alph}(w_1) = \operatorname{alph}(w_2) = B$.

Second Case: Operation (2). $B \in \alpha(q_1,q_1,q_2,q_2), \alpha(r_1,r_1,r_2,r_2)$ and there exists words $u_1,u_2 \in B^*$ such that $q_1 \xrightarrow{u_1} r_1$ and $q_2 \xrightarrow{u_2} r_2$. By induction hypothesis, there exist words v_1,v_2,x_1,x_2 with alphabet B such that $v_1 \cong_{\kappa} v_2, x_1 \cong_{\kappa} x_2$, $\mathsf{alph}(v_1) = \mathsf{alph}(v_2) = \mathsf{alph}(x_1) = \mathsf{alph}(x_2) = B, \ q_1 \xrightarrow{v_1} q_1, \ r_1 \xrightarrow{x_1} r_1, \ q_2 \xrightarrow{v_2} q_2$ and $r_2 \xrightarrow{x_2} r_2$. Set $\kappa \in \mathbb{N}$ and set $w_1 = (v_1)^{|B|\kappa} u_1(x_1)^{|B|\kappa}$ and $w_2 = (v_2)^{|B|\kappa} u_2(x_2)^{|B|\kappa}$. By definition, it is clear that $\mathsf{alph}(w_1) = \mathsf{alph}(w_2) = B, \ q_1 \xrightarrow{w_1} r_1$ and $q_2 \xrightarrow{w_2} r_2$. Moreover, since $\mathsf{alph}(v_1) = \mathsf{alph}(x_1) = B, \ (v_1)^{|B|\kappa}$ and $(x_1)^{|B|\kappa}$ are (B,κ) -patterns. Observe that because $v_1 \cong_{\kappa} v_2, x_1 \cong_{\kappa} x_2$, we have

$$w_2 = (v_2)^{|B|\kappa} u_2(x_2)^{|B|\kappa} \cong_{\kappa} (v_1)^{|B|\kappa} u_2(x_1)^{|B|\kappa}$$

Therefore it suffices to prove that

$$w_1 = (v_1)^{|B|\kappa} u_1(x_1)^{|B|\kappa} \cong_{\kappa} (v_1)^{|B|\kappa} u_2(x_1)^{|B|\kappa}$$

in order to conclude that $w_1 \cong_{\kappa} w_2$ and end the proof. This last equivalence is a consequence of the following lemma.

Lemma 12. Let $\kappa' \in \mathbb{N}$, and let $u, v \in B^*$ be two words that are both (B, κ') -patterns. Then for all words w_1, w_2 , the following equivalence holds:

$$u \cdot w_1 \cdot v \cong_{\kappa'} u \cdot w_2 \cdot v.$$

Proof. We begin by observing a simple property of unambiguous products.

Remark 1 Let $B_0^*c_1B_1^*\cdots B_{\kappa'-1}^*c_{\kappa'}B_{\kappa'}^*\subseteq B^*$ be an unambiguous product. There can be at most one set B_i such that $B_i=B$.

Let $P = B_0^* c_1 B_1^* \cdots B_{\kappa'-1}^* c_{\kappa'} B_{\kappa'}^*$ an unambiguous product of size κ' and assume that $uw_1v \in P$. We prove that $uw_2v \in P$. Since $uw_1v \in P$, there exists some decomposition

$$uw_1v = x_0c_1x_1\cdots x_{\kappa'-1}c_{\kappa'}x_{\kappa'}$$

that is a witness. If no set B_i is the whole alphabet B, then uw_1v is at most a κ' -pattern, which is impossible since it is by definition a $2\kappa'$ -pattern. Therefore, by Remark 1 there is exactly one set B_i such that $B_i = B$. It follows that the words $x_0c_1x_1\cdots x_{i-1}$ and $c_{i+1}\cdots x_{\kappa'-1}c_{\kappa'}x_{\kappa'}$ are at most $\kappa'-1$ -patterns. Therefore, they are respectively a prefix of u and a suffix of v (which are κ' -patterns). It follows that there exists some word y_i such that

$$uw_2v = x_0c_1x_1\cdots x_{i-1}y_ic_{i+1}\cdots x_{\kappa'-1}c_{\kappa'}x_{\kappa'}.$$

Such a decomposition for uw_2v is witness for membership in P. We conclude that $uw_2v \in P$.
