## Student Conduct during Examinations

1. (a) Compute the equation of the plane which contains the points $A=(2,1,1), B=$ $(2,2,3)$ and $C=(1,-1,-2)$ and write it in the form $a x+b y+c z=d$.

Solution: Use $A$ as a base point and form the vectors $\overrightarrow{A B}=\langle 2,2,3\rangle-\langle 2,1,1\rangle=$ $\langle 0,1,2\rangle$ and $\overrightarrow{A C}=\langle 1,-1,-2\rangle-\langle 2,1,1\rangle=\langle-1,-2,-3\rangle$. Use both vectors to compute a normal vector to the plane using the cross product $\overrightarrow{A B} \times \overrightarrow{A C}$. Now, $\overrightarrow{A B} \times \overrightarrow{A C}=\langle 1,-2,1\rangle$, so the solution is of the form $x-2 y+z=d$. Plugging any of the three points yields that $d=1$. Note that the solution $-x+2 y-z=-1$ is also correct.

Answer: $x-2 y+z=1$.
2 marks (b) Consider the point $D=(0,1, t)$ where $t$ is a value such that $D$ in the plane which contains $A, B$ and $C$. Determine the value of $t$.

Solution: Replacing $(0,1, t)$ in the plane equation yields $0-2+t=1$, therefore $t=3$.

Answer: $t=3$.
4 marks (c) What angle does the plane from (a) form with the plane given by the equation $x-y=0$ ?

Solution: A vector which is normal to the plane $x-y=0$ is $\vec{n}=(1,-1,0)$. A normal vector to the first plane is $\vec{m}=(1,-2,1)$. We can use the dot product formula to obtain that $\cos \theta=\frac{\vec{n} \cdot \vec{m}}{\|\vec{m}\|\|\vec{n}\|}=\frac{3}{\sqrt{2} \sqrt{6}}$.

Answer: $\theta=\cos ^{-1}\left(\frac{\sqrt{3}}{2}\right)=\frac{\pi}{6}$
2. In the box below each plot, place a function from the list below which could generate that plot. There are two functions which are not associated to any plot. You do not need to justify your answers.

3. (a) Let $u(x, y)=\sin (x+3 y)+(x-3 y)^{3}$. Compute the partial derivatives $u_{x}, u_{y}, u_{x x}$ and $u_{y y}$.

Answer: $u_{x}=\cos (x+3 y)+3(x-3 y)^{2}$.
Answer: $u_{y}=3 \cos (x+3 y)-9(x-3 y)^{2}$
Answer: $u_{x x}=-\sin (x+3 y)+6(x-3 y)$
Answer: $u_{y y}=-9 \sin (x+3 y)+54(x-3 y)$
4 marks (b) Determine for which values $a \in \mathbb{R}$ is $u(x, y)$ a solution of the equation

$$
\frac{\partial^{2} u}{\partial y^{2}}+a^{3}\left(\frac{\partial^{2} u}{\partial x \partial y}-\frac{\partial^{2} u}{\partial y \partial x}\right)=a^{2} \frac{\partial^{2} u}{\partial x^{2}} .
$$

Answer: $a=-3$ and $a=3$.
Solution: As $\frac{\partial^{2} u}{\partial x \partial y}=\frac{\partial^{2} u}{\partial y \partial x}$ the equation above simplifies to

$$
\frac{\partial^{2} u}{\partial y^{2}}=a^{2} \frac{\partial^{2} u}{\partial x^{2}}
$$

Replacing the solutions obtained above we obtain that $a^{2}=9$, and thus the only solutions are $a=-3$ and $a=3$.

4. (a) Consider the function $f(x, y)=\ln (x y)$. Draw a sketch of largest possible domain $D \subset \mathbb{R}^{2}$ where $f$ is well defined. Does it contain the lines defined by $y=0$ and $x=0$ ?


4 marks (b) What is the equation of the tangent plane to $f(x, y)=\ln (x y)$ passing through $\left(x_{0}, y_{0}\right)=(1,1) ?$

$$
\text { Answer: } z=x+y-2
$$

Solution: The equation of the tangent plane to the surface at the point $\left(x_{0}, y_{0}\right)$ is $z=f\left(x_{0}, y_{0}\right)+\frac{\partial f}{\partial x}\left(x_{0}, y_{0}\right)\left(x-x_{0}\right)+\frac{\partial f}{\partial y}\left(x_{0}, y_{0}\right)\left(y-y_{0}\right)$.
The partial derivatives are $\frac{\partial f}{\partial x}=\frac{1}{x}$ and $\frac{\partial f}{\partial y}=\frac{1}{y}$. Replacing the values $x_{0}=$ $1, y_{0}=1$ yields $f(1,1)=0, \frac{\partial f}{\partial x}(1,1)=1$ and $\frac{\partial f}{\partial y}(1,1)=1$, therefore the equation is $z=(x-1)+(y-1)$.
(c) The volume of the ellipsoid $\frac{x^{2}}{a^{2}}+\frac{y^{2}}{b^{2}}+\frac{z^{2}}{c^{2}}=1$ is given by the expression $V=\frac{4 \pi}{3} a b c$. Suppose that the values of $a, b, c$ are known up to an error $\Delta a=\Delta b=\Delta c=$ $\frac{3}{400 \pi}$. Give an estimation of the error $\Delta V$ on the volume of the ellipsoid using total differentials. Leave your answer in expressed in terms of $a, b, c$.

Answer: $\mathrm{d} V=\frac{1}{100}(b c+a c+a b)$
Solution: In general if $z=g(x, y, z)$ we have $\mathrm{d} z=\frac{\partial g}{\partial x}(x, y, z) \mathrm{d} x+\frac{\partial g}{\partial y}(x, y, z) \mathrm{d} y+$ $\frac{\partial g}{\partial z}(x, y, z) \mathrm{d} z$. Computing these partial derivatives and replacing the differentials by the given value yields the result.

1 mark (d) Find the estimation on the error $\Delta V$ above when $a=50, b=40$ and $c=30$.
Answer: $\Delta V=47$
Solution: Replacing we get

$$
\begin{aligned}
\mathrm{d} V & =\frac{1}{100}(40 \cdot 30+50 \cdot 30+50 \cdot 40) \\
& =\frac{1}{100}(1200+1500+2000) \\
& =47
\end{aligned}
$$
